

Dear Secretary,

The Pradhan Mantri Rashtriya Bal Puraskar (PMRBP) is a prestigious national award conferred by the Government of India to recognize such exceptional achievements of children in various fields which have positively impacted society and which can be a source of inspiration to other children. Instituted to honor such public spirited young individuals, the award is given under six categories: **Bravery, Social Service, Environment, Sports, Art & Culture and Science & Technology**. Children below the age of 18 years (as on 31st July, 2026) who have made outstanding public contributions in these fields are eligible to be nominated.

2. To ensure a broad-based selection process, nominations for PMRBP are invited from all Ministries and Departments of the Government of India, State Governments, Union Territories and other relevant institutions. The nominations/recommendations for PMRBP will be received only online through the Rashtriya Puraskar Portal (<https://awards.gov.in>) designed for this purpose.

3. It has been observed that while a large number of nominations are received each year, many deserving children may go unnoticed as they neither seek public attention nor publicity. Children who have faced greater hardships in achieving excellence need to be identified. It is, therefore, requested to make concerted efforts in identifying only such children whose excellence and achievements deserve to be recognized by society and government.

4. Therefore, I request you to kindly send suitable nominations for the PMRBP. The following aspects may kindly be ensured:

- The recommended children are exceptionally deserving of national level award where positive social externalities are of a high order.
- Special efforts are made to identify talented children from among girls, weaker sections, SC and ST communities and Divyang persons.

5. The online nominations/recommendations for the PMRBP have started from 1st April, 2026 and the last date for nominations is 31st July, 2026.
