On completion of the same, the Committee will submit its findings to Registrar, APTEL for further necessary action.
- 3. The Committee shall make itself effective and functional at all times. It should also meet once a quarter even if there is no live case and review the preparedness to fulfil all requirements.
- 4. The Committee will also submit an annual report of the complaints received and action suggested by the Committee to Administration Section of this Tribunal.
- 5. The Committee shall work in accordance with the provisions of Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013, notification by Ministry of Women & Child Development issued vide GSR 769€ dated 09.12.2013 and DoP&T OMs No.11013/2/2014-Estt.(A.III) dated 27.11.2014 and 02.02.2015, as amended form time to time.
